

# CLUB REGULATIONS AND CONTRACT

Last Updated: January 2010

1. Blaze orange hat required. 50% blaze orange required during gun deer season.
2. Hunters must stay within assigned areas.
3. All hunters must adhere to the laws of the State of Wisconsin governing the operation of a game farm.
4. Oct 1, 2010 to Feb 28, 2011 hunt times are: (8:00 AM - 12:00 PM) or (12:30 PM - 4:30 PM)  
Mar 1, 2011 to Apr 15, 2011 hunt times are: (7:30 AM - 10:30 AM), (11:00 AM - 2:00 PM) or (2:30 PM - 5:30 PM).
5. Memberships run May 1, 2010 to April 30, 2011. Hunting season runs October 1, 2010 to March 31, 2011, except for .410 and 28 Gauge Memberships.
6. Memberships will not be prorated based on date of joining.
7. Reservations for hunt times should be placed at least 24 hours in advance. Cancellations must be made at least 48 hours in advance (unless due to bad weather), otherwise your account will be charged the minimum release for that day.
8. Members must check-in at the clubhouse before AND after hunting.
9. 4 hunters maximum per field.
10. Minimum pheasant release: (except the .410 Membership)  
October 1 through January 2:  
6 pheasants per field Tue.-Thur.  
8 pheasants per field Fri.-Sun.  
January 4 through March 31:  
8 pheasants per field Tue.-Thur.  
10 pheasants per field Fri.-Sun.
11. Payment is on a "BIRD RELEASED" basis. Although we do our best to see that you get your birds, we cannot guarantee the abilities of dogs & shooters.
12. Must use membership/contracted birds by March 31st and before purchasing additional birds. (Excluding specials.)
13. Please make sure you are familiar with Milford Hills Hunt Club boundaries before hunting.
14. Anyone below the age of 16 must have attended a Hunter Safety Course and have in his or her possession a Hunter Safety Certificate. Youth at least 10 years of age can hunt within arms reach of a qualified mentor provided they share the same firearm.
15. House accounts for clubhouse purchases are available only with 16 Gauge, 12 Gauge and 10 Gauge Magnum Memberships. House accounts need a credit card number on file. On Account receipt must be signed upon departure, this will be your invoice. All open accounts will be charged to credit cards on file the 1st and 15th of every month.
16. Dog work and training will be allowed during the summer months.
17. Dogs must stay on a leash until in designated hunting field. Wild-running or untrained dogs are not permitted. Members are encouraged to use their own dogs. Pups of training age are permitted.
18. No shooting within 250 feet of any occupied buildings and no shooting within 100 feet of paved roads.
19. No consumption of alcohol permitted before hunting.
20. No unreleased birds will be carried over to the following season.
21. Payment must be received within 10 days after invoice date. Late charge of 1.5% per month or 18% annum.
22. No birds allocated until complete membership is paid in full.
23. Please pick up your empty shells and other litter.
24. Please be careful with matches and cigarette butts while afield.
25. No carry-ins of food or beverages allowed in the clubhouse.
26. Memberships are subject to revocation without refund for violation of club rules, poor sportsmanship, or misconduct as determined by management.
27. Membership packages including birds will not be refundable.
28. Bird cleaning is not included in memberships.
29. Cancellation of dog & handler within 24 hours of scheduled hunt will incur the fee of dog & handler. To cancel a dog and handler you **must talk directly to a staff member** of Milford Hills Hunt Club.
30. All members of the hunting party must sign a waiver before hunting.
31. All club rules are subject to change, as conditions require. Such changes to be made in the best interest of all members.
